As chair, I set the agenda, presided over monthly meetings; and in so doing oversaw the shared governance process with the Administration, the University Senate, and other pertinent policy making bodies.

Helped restructure the General Education requirements for the entire college of arts and sciences and tended to other duties as needed.

This position also calls for the director to smooth out whatever rough patches that arise between, not only advisee and faculty members, but issues that may develop between graduate students and faculty members in classroom settings.

As director I was responsible for every aspect of the operation, from maintaining the 7,000 square foot facility to managing the budget to supervising employees to making sure our webpage was user friendly and current. Finally, as Director I was also the CEC's principal fundraiser.

Of the fifteen programs and activities offered at the CEC, twelve were created under my stewardship. We offered a range of programs that were designed to enhance the life chances of both students and those who resided and worked in the historic neighborhood of Bronzeville. Among the initiatives we offered were a plethora of credit, noncredit and continuing education courses for traditional, non-traditional students as well as life-long learners.

Aside from courses, we offered a plethora of programs and activities. A selected list includes a: college prep summer residential program for rising eleventh and twelfth graders, a math-science camp for youth in grades 4<sup>th</sup> through 8<sup>th</sup> and 9<sup>th</sup> through 12<sup>th</sup>, computer literacy courses for senior citizens; and a leadership development course for young professionals that I co-directed with a former state senator, to name a few. See below for details.

**Among the *responsibilities* for which I was charged, included:**

- Course scheduling
- Setting agenda and promoting high academic standards in instruction
- Overseeing Enrollment management
- Facilitating the review and approval process for establishing new certificate programs and for overseeing the curricular planning and development for the Community Extension Center.
- Creating data driven reports that demonstrated program effectiveness.
- Creating opportunities for interaction between students, faculty, community stakeholders and industry leaders.

- Identifying the community extension center's needs for program coordinator positions, establish hiring priorities, and making recommendations to the executive dean and or provost.
- Providing faculty with the resources necessary to be successful.
- Fostering research projects.
- Establishing relationships with k-12, community college and other area colleges instructors and administrators
- Providing oversight for the financial affairs of the community extension center, including budget development and allocation.
- Raising funds for programming.
- Guiding short and long-range planning of capital improvement projects.
- Enhancing, promote, and developing alumni networks.
- Overseeing the operations of the community extension center and providing direction to its staff.

### *Selected Accomplishments*

- Raised an unprecedented 1.5 million dollars
- Created a slate of new courses, including a service-learning course titled *Service-learning in Urban Communities: Get out the Vote*
- Created a 16-page quarterly newspaper titled the *Bronzevillian*. Issues can be found online.
- Provided publishing opportunities for both undergrad and graduate students
- Helped recruit students from HBCUs to graduate school here at OSU
- Moved the Ohio Commission on African American Males, a state agency, to the African American and African Studies Community Extension Center at the Ohio State University
- Created thirteen new programs
- Created a 10-week leadership program
- Established a Rites of Passage Program for African American boys
- Created workshops that promoted and created professional development opportunities for both faculty members of color and graduate students
- Shepherded forty-five kids from our summer programs into four-year colleges including several HBCUs
- Helped dozens of undergraduates get admitted into graduate and professional schools
- Mentored several graduate students through their respective M.A. and doctoral degree programs.

--Established an informal mentor-mentee effort that connected young aspiring leaders with more seasoned change agents in the community.

--Established partnerships with OSU Medical East, Veterans groups, non-profit agencies such as The Dr. Martin Luther King, Jr. Arts Complex, the Urban League and the Girl Scouts of America, as well as OSU's Departments of Nursing, Geography, English, City and Regional Planning. Corporations that we cultivated include, but not limited to the Wendy's Corporation, the Moody-Nolan Architectural firm as well as various neighborhood associations such as the Bronzeville Neighborhood Association and the Mount Vernon District Improvement Association.

--Conducted studies/wrote white papers that had real-world application on the Bronzeville community.

Because I was charged with such things as course scheduling at the CEC, enrollment management and promoting high academic standards, I found myself in the unenviable position of overseeing/supervising faculty. For instance, one of the ideas that I brought to the Community Extension Center (CEC) upon my arrival in 2006-2007 was the addition of for-credit courses, for both undergraduate and graduate students. The CEC is located in a prime location, about twenty minutes from OSU's campus, in the historic Black neighborhood of Bronzeville. It is within walking distance of some of the city's most hallowed landmarks--the King Arts Complex, the Lincoln Theater, the Neighborhood House, Jobs and Family Services and the Urban League as well as two middle schools and one high school. One of the reasons I deemed it a good idea to offer courses at the CEC was to create a synergy between the CEC and those other entities that had the potential to produce a once in a lifetime educational experience for those involved. Teaching at the CEC offered a range of pedagogical opportunities, hence the reason I made sure to elicit proposals from faculty members who were especially interested in teaching a range of service-learning courses. Faculty members enjoyed teaching at the CEC for a variety of reasons, one of which has to do with proximity to the agencies and landmarks cited above. Also parking is in abundance and without hassle. There is no cost or time restrictions associated with parking at the CEC.

During my second year at OSU, I put out a campus call for proposals to teach at the CEC, outlining the advantages of doing so. The response was impressive. Proposals were sent to me and members of my team. Only those proposals that meshed with our mission were selected. Suffice to say, proposals went through a

rigorous screening process with the final decision resting with me. Because these courses were held at the CEC they were open to the public. Each course was allowed to have a maximum of five non OSU students audit/sit-in on the class. The idea was to make OSU's resources available to interested parties who otherwise would not be presented with such an opportunity. Each faculty member was expected to adhere to the same standards at this off-campus site had the course been held on campus. Any rescheduling of classes had to have my approval before moving forward. Any faculty member seeking to apply for a grant that involved the course they were teaching needed my approval. Faculty members whose courses called for certain kinds of equipment needed to make that clear from the outset so that arrangements could be made in cooperation with me to ensure effective and timely delivery of classroom instruction.

On a related note, faculty members who did not teach at the CEC, but endeavored to use the facility for research purposes had to have my approval and were required to abide by the guidelines set forth by the university. As director of the CEC, I was responsible for making sure that faculty members adhered to university standards regarding an array of matters ranging from issues concerning human subjects, especially children under the age of eighteen, and the like. Because classes were held at the CEC on a consistent basis I sometimes had to mediate disputes between colleagues who thought they had a right to a particular space despite not having scheduled such or having office hours on that particular day. In other words, I had to ensure that faculty members did not infringe on other colleagues' right to space and time. I also had to sometimes step in when differences of opinion caused tension between faculty members and our more seasoned undergraduate and graduate students. Oftentimes, these issues would be brought to my attention during my monthly meetings with faculty. These informal meetings allowed me to stay abreast of things.

Faculty members in African American and African Studies, Nursing, OSU Medical East, Geography, Mathematics, urban and regional Planning, English, Engineering, Architecture and Landscaping, Sociology, Political Science and Social Work were some of the faculty with whom I worked to create a unique educational experience that I believe benefitted both professor and students, alike.

**Fall 2006-Spring 2012**      **Co-Director**, The Ray Miller Institute for Leadership and Change Named in honor of former State Senator Ray Miller, I co-founded this effort in the summer of 2006. This 10-week leadership institute for those 21 and older was designed to equip young professionals with the necessary skills to make a difference in the communities in which they lived and or worked. The leadership institute received awards from the Columbus City Council and the National Council for Black Studies, Inc.
